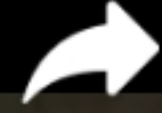

UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT
("Undertaking")

of

MS. NESSRINE HUSSEIN

to

COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO
(the "College")

A. PREAMBLE

- (1) I, **Nessrine Hussein**, acknowledge that the College initiated an investigation into whether I am operating in contravention of the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18, as amended (*RHPA*) and/or the *Medicine Act, 1991*, S.O. 1991, c. 18 (*Medicine Act*).
- (2) I, **Nessrine Hussein**, acknowledge that I am not a member of the College or of any other regulated health profession under the *RHPA*.
- (3) I, **Nessrine Hussein**, acknowledge that I have performed Controlled Acts in contravention of the *RHPA*. The College has provided me with a copy of the relevant provisions of the *Medicine Act* and the *RHPA*. The College has advised me that I am operating in contravention of the statutes noted above in paragraph (1), and further advised me that violating certain provisions of these statutes constitute an offence at law.

B. UNDERTAKING

- (4) I, **Nessrine Hussein**, undertake to abide by the provisions of this Undertaking, effective immediately.

5) RESTRICTIONS


- i. I, **Nessrine Hussein**, undertake that in the course of providing health care services to any individual I will permanently refrain from performing controlled acts except in compliance with section 27 of the *RHPA*.

ACKNOWLEDGEMENT



- (7) I, **Nessrine Hussein**, acknowledge that a breach by me of any provision of this Undertaking may result in the College taking legal action against me, including commencing an application in court for injunctive relief.
- (8) I, **Nessrine Hussein**, acknowledge that the College may provide this Undertaking and/or any other relevant information to any organization or academic institution to which you have claimed to be a member and/or a graduate.
- (9) I, **Nessrine Hussein**, acknowledge that this Undertaking may be posted on the College's website: <http://www.cpsso.on.ca/> under Unregistered Practitioners as notification to the public that I am not a registered member of the College.
- (10) I, **Nessrine Hussein**, acknowledge that the College will continue to monitor my compliance with the provisions of this Undertaking.


