ORDER

ON READING the Application Record, Factum and Brief of Authorities of the Applicant, and the Consent of the parties, filed,

1. THIS COURT ORDERS that:

- i) Allan Zangwill Seltzer must comply with section 33 of the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18, and section 9 of the *Medicine Act, 1991*, S.O. 1991, c. 30, and in particular must permanently refrain from:
 - a) using the title “doctor” and any variation or abbreviation thereof, or equivalent in another language, in the course of providing or offering to provide, health care, including counseling and psychotherapy, to individuals in Ontario;
 - b) using the title “physician” and any abbreviation or variation thereof, or equivalent in another language;


- c) holding himself out as a person who is qualified to practice in Ontario as a physician or in a specialty of medicine, including psychiatry, including through the use of the title “psychiatrist” and through the use of the designations MD, FRCP, MRCP, MRCPsych, and DipPsync, and any other designations associated with the practice of medicine or psychiatry.
- ii) Allan Zangwill Seltzer must immediately remove, and must permanently refrain from displaying, the following on any website, advertisement, brochure, business card, receipt, letterhead, or other document connected to or associated with his provision of counseling, psychotherapy or other health care services:
- a) all references to himself using the title “doctor”, and variations or abbreviations thereof, including M.D., including but not limited to references contained within his email addresses;
 - b) all references to himself using the titles “physician” and “psychiatrist”;
 - c) all references to himself indicating that he is or was a physician or psychiatrist, including references to positions he has held or training he has received in these capacities;
 - d) all references to himself using or adopting the initials “MD”, “FRCP”, “MRCP”, “MRCPsych”, or “DipPsync”;
 - e) all claims that he is “board certified”;
 - f) all references to his psychotherapy or counseling clients as “patients”;
 - g) all references to the his fees as “medical expenses”; and
 - h) any other references, claims or assertions which fail to comply with the *Regulated Health Professions Act* and the *Medicine Act*.

2. THIS COURT FURTHER ORDERS that this Application is otherwise dismissed without costs.
