ORDER

THIS MOTION, made by the Respondent, Eve Stewart, for an adjournment of the Application made by the Applicant, was heard this day at 393 University, Toronto, Ontario.

ON READING the Application Record, Factum, and the Brief of Authorities of the Applicant, and on hearing the submissions of Counsel for the Applicant and the Respondent, Eve Stewart, appearing in person,

1. THIS COURT ORDERS that the Application is adjourned to Motion Scheduling Court on March 7, 2014 on the following terms:

- i) the adjournment is peremptory on Ms. Stewart;
- ii) pending the resolution of the Application, Eve Stewart, her employees, servants, agents or any person acting in association with her or under her instructions must comply with sections 27 and 30 of the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18, and in particular refrain from:

- a) performing controlled acts in the course of providing health care services to any individual including but not limited to:
- communicating to the individual or his or her representative a diagnosis identifying a disease or disorder as the cause of symptoms of the individual in circumstances in which it is reasonably foreseeable that the individual or his or her personal representative will rely on the diagnosis;
 - performing a procedure on tissue below the dermis, below the surface or the mucus membrane;
 - administering a substance by injection or inhalation; and
 - putting an instrument, hand or finger beyond the point in the nasal passages where they normally narrow, or beyond the labia majora; and
- b) treating or advising a person with respect to his or her health in circumstances in which it is reasonably foreseeable that serious bodily harm may result from the treatment or advice or from an omission from them.

2. THIS COURT FURTHER ORDERS that costs of this day be reserved to the Application Judge.
