

Charges

Surname: Yusak, under the pseudonym 'Harvey Archambeau' was charged with the following offences:

1. Assault, use of a weapon, namely a syringe, on or about August 28, 2024, contrary to section 267(a) of the Criminal Code of Canada.
2. Assault, use of a weapon, namely a syringe, on or about October 5, 2024, contrary to section 267(a) of the Criminal Code of Canada.
3. Assault, use of a weapon, namely a syringe, on or about October 26, 2024, contrary to section 267(a) of the Criminal Code of Canada.
4. Fraud not exceeding \$5,000, on or about August 28, 2024, contrary to s. 380(1)(b) of the Criminal Code of Canada
5. Fraud not exceeding \$5,000, between October 5 and October 26, 2024, contrary to s. 380(1)(b) of the Criminal Code of Canada
6. Assault, use of a weapon, namely a syringe, on or about August 29, 2024, contrary to section 267(a) of the Criminal Code of Canada.
7. Fraud not exceeding \$5,000, on or about August 29, 2024, contrary to s. 380(1)(b) of the Criminal Code of Canada
8. Assault, use of a weapon, namely a syringe, on or about August 29, 2024, contrary to section 267(a) of the Criminal Code of Canada.
9. Fraud not exceeding \$5,000, on or about August 29, 2024, contrary to s. 380(1)(b) of the Criminal Code of Canada
10. Assault, use of a weapon, namely a syringe, on or about October 5, 2024, contrary to section 267(a) of the Criminal Code of Canada.
11. Assault, use of a weapon, namely a syringe, on or about October 31, 2024, contrary to section 267(a) of the Criminal Code of Canada.
12. Fraud not exceeding \$5,000, between October 5 and October 31, 2024, contrary to s. 380(1)(b) of the Criminal Code of Canada
13. Common nuisance by doing an unlawful act, namely not being qualified in Canada to inject into people substances purported to be Salmon DNA, Botox, and Ozempic, and by

doing do endanger the lives safety health of the public between August 28, 2024 and October 31, 2024, contrary to section 180(1)(a) of the Criminal Code of Canada.

Release Conditions

On December 9, 2024, the following Release Conditions were imposed on Yusak:

1. Yusak must provide a cash deposit of \$2000 to be made at a courthouse within 24 hours of release.
2. Yusak must report to the Toronto Ontario court of Justice (Bail Program) on the business day following release, and thereafter as directed. Be under the direction and supervision of the program and be amenable to its rules and regulations.
3. Yusak must not contact or communicate in any way either directly or indirectly, by any physical, electronic or other means, with named persons.
4. Yusak must not be within 100 metres of any place where he knows named persons to live, work, go to school, frequent or any place he knows named persons to be EXCEPT for required court appearances.
5. Yusak must not attend within 100 metres of Love Park located at 96 Queens Quay W, Toronto, ON.
6. Yusak must not possess:
 - any weapon(s) as defined by the Criminal Code (for example, but not restricted to, a pellet gun, firearm, imitation firearm, cross-bow, prohibited or restricted weapon or device, ammunition or explosive substance or anything designed to be used or intended for use to cause death or injury or to threaten or intimidate any person).
7. Yusak must deposit passport/travel documents to Detective #4549 or his designate at 52 Division (416) 808-5200 within 48 hours of his release.
8. Yusak must not possess any medical tools, supplies or prescription for the purposes of administering medication.
9. Yusak must not possess any prescription medication not in his name.
