

**UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT
("Undertaking")**

of

MS. CARMENZA CHARRY

to

**COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO
(the "College")**

A. PREAMBLE

- (1) I, **Carmenza Charry**, acknowledge that the College initiated an investigation into whether I am operating in contravention of the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18, as amended (*RHPA*).
- (2) I, **Carmenza Charry**, acknowledge that I am not a member of the College or of any other regulated health profession under the *RHPA*.
- (3) I, **Carmenza Charry**, acknowledge that I have performed Controlled Acts without authority in the course of providing or offering to provide health care to individuals. The College has provided me with a copy of the relevant provisions of the *RHPA*. The College has advised me that I am operating in contravention of the statute noted above in paragraph (1), and further advised me that violating certain provisions of these statutes constitute an offence at law.

B. UNDERTAKING

- (4) I, **Carmenza Charry**, undertake to abide by the provisions of this Undertaking, effective immediately.

(5) RESTRICTIONS

- (a) I, **Carmenza Charry**, undertake that I will permanently refrain from using the titles "doctor", "Dr." and/or any variation or abbreviation thereof, in the course of providing health care services to any individual, and further undertake not to hold myself out as a doctor. In doing so, I will:

- i. Only perform controlled acts in compliance with section 27(1) of the *RHPA*

C. ACKNOWLEDGEMENT

- (6) I, **Carmenza Charry**, acknowledge that I have read and understand the provisions of this Undertaking and that I have obtained independent legal counsel in reviewing and executing this Undertaking, or have waived my right to do so.

- (7) I, **Carmenza Charry**, acknowledge that a breach by me of any provision of this Undertaking may result in the College taking legal action against me, including commencing an application in court for injunctive relief.
- (8) I, **Carmenza Charry**, acknowledge that the College may provide this Undertaking and/or any other relevant information to any organization or academic institution to which you have claimed to be a member and/or a graduate.
- (9) I, **Carmenza Charry**, acknowledge that this Undertaking may be posted on the College's website: <http://www.cpsso.on.ca/> under Unregistered Practitioners as notification to the public that I am not a registered member of the College.
- (10) I, **Carmenza Charry**, acknowledge that the College will continue to monitor my compliance with the provisions of this Undertaking.


