ORDER

THIS APPLICATION, made by the Applicant, the College of Physicians and Surgeons of Ontario, for an order under section 87 of the Health Professions Procedural Code, being Schedule 2 to the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18 granting the within application, was heard on November 19, 2025.

ON READING the Application Record of the Applicant (Volumes 1 and 2), the Reply Application Record of the Applicant, the Brief of Transcripts of the Applicant, the Factum of the Applicant, the Brief of Authorities of the Applicant, the affidavit of Luoyan Zheng sworn July 17, 2025, the affidavit of Reza Ghalamghash sworn July 18, 2025, the affidavit of Kun Yu sworn July 18, 2025, the transcript of the cross-examination of Dr. Jimmy Poon dated September 4, 2025, and the Factum of the Respondent, and on hearing submissions from the lawyers for the parties,

AND FOR WRITTEN REASONS dated November 21, 2025,

1. **THIS COURT ORDERS** that the Respondent, Reza Ghalamhash, shall comply with sections 27, 30, and 33 of the *Regulated Health Professions Act, 1991*, S.O. 1991, c.18, and sections 4 and 9 of the *Medicine Act, 1991*, S.O. 1991, c. 30, and in particular:

- (a) the Respondent, Reza Ghalamhash, shall permanently refrain from:
 - (i) using the title “doctor” and any variation or abbreviation thereof, including “Dr.”, in the course of providing or offering to provide, in Ontario, health care to individuals;
 - (ii) using the titles “physician”, “surgeon” or “dermatologist”, or any variation or abbreviation thereof;
 - (iii) holding himself out as a person qualified to practice in Ontario as a physician, surgeon, or in a specialty of medicine, such as dermatology;
 - (iv) performing or offering to perform any controlled act, including but not limited to:
 - 1. performing a procedure below the dermis (including but not limited to thread lifts); and
 - 2. administering a substance by injection (including but not limited to Botox injections, mesotherapy injections, and platelet-rich plasma injections);
 - (v) treating or advising a person with respect to his or her health in circumstances in which it is reasonably foreseeable that serious bodily harm may result from the treatment or advice or from an omission from the treatment or advice; and
- (b) the Respondent, Reza Ghalamhash, shall immediately remove, and permanently

refrain from displaying or permitting to be displayed on any website, social media account, email address, advertisement, brochure, business card, receipt, letterhead, or other document connected to or associated with his provision of any health care service in Ontario:

- (i) all references to the Respondent using the title “doctor” and any variations or abbreviations thereof, as it relates to providing or offering to provide, in Ontario, health care service to individuals;
- (ii) all references to the titles “physician”, “surgeon”, and “dermatologist” as applied to the Respondent;
- (iii) all references that the Respondent performs, or is permitted to perform, any controlled act, including but not limited to
 1. performing a procedure below the dermis (including but not limited to thread lifts); and
 2. administering a substance by injection (including but not limited to Botox injections, mesotherapy injections, and platelet-rich plasma injections); and
- (iv) any other references, claims or assertions that fail to comply with the *Regulated Health Professions Act*, and the *Medicine Act*.

2. **THIS COURT FURTHER ORDERS THAT** this Order preserves the ability of the Respondent, Reza Ghalamghash, to bring a motion, on notice to the College of Physicians and Surgeons of Ontario, to vary this Order to permit him to perform and/or offer to perform one or more controlled acts pursuant to delegation by a member of a College authorized by a health profession Act to perform the controlled act or acts.

3. **THIS COURT FURTHER ORDERS THAT** the Respondent, Reza Ghalamghash, pay costs to the College, together with applicable Harmonized Sales Tax, in the amount of \$35,000.00, within 30 days of the date of this Order.

THIS ORDER BEARS INTEREST at a rate of 4.0% per year commencing from the date of this Order.
