

UNDERTAKING, ACKNOWLEDGEMENT, AND CONSENT
("Undertaking")

of

MR SHAHIN POURGOL
("Mr. Shahin Pourgol")

to

COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO
(the "College")

PREAMBLE

- (1) I, **Mr. Shahin Pourgol**, acknowledge that the College initiated an investigation into whether I am operating in contravention of the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18, as amended (*RHPA*) and the *Medicine Act, 1991*, S.O. 1991, c. 18 (*Medicine Act*). S.P.
- (2) I, **Mr. Shahin Pourgol**, acknowledge that on a prior occasion, in 2015, the College advised me that I was operating in contravention of the *RHPA*. I further acknowledge that I confirmed to the College in writing my receipt of its correspondence in this regard. S.P.
- (3) I, **Mr. Shahin Pourgol**, acknowledge that I do not provide or offer to provide health care to any individuals in Ontario or in any other jurisdiction in Canada. Without limiting the foregoing, I specifically do not perform or engage in any practice of chiropractic or osteopathic medicine in Canada. S.P.
- (4) I, **Mr. Shahin Pourgol**, acknowledge that on February 14, 2014 the College of Chiropractors of Ontario (CCO) held a discipline hearing into my conduct, which included my use of the title "osteopath". S.P.
- (5) I, **Mr. Shahin Pourgol**, acknowledge that at the conclusion of the hearing the Registrar of the CCO imposed the following terms, conditions and limitations on my certificate of registration: S.P.
 - (i) he will not use the title "osteopath"; S.P.
 - (ii) he will not hold himself out as a person who is qualified to practice in Ontario as an osteopath; S.P.
 - (iii) he will not use the title "osteopath" in the course of providing or offering to provide health care to individuals in Ontario; S.P.

- (iv) he will not perform any of the controlled acts set out in section 27(2) of the *Regulated Health Professions Act, 1991*; S.F.
- (v) he will resign his membership with the CCO within six months of the date of the Panel's decision in this matter. S.F.
- (6) I, **Mr. Shahin Pourgol**, acknowledge that I resigned my certificate of registration with the CCO in 2014, and confirm that I am not a member of the College or of any other regulated health profession in Ontario. I further acknowledge that the College has no evidence that I have provided health care to any individual after the date of my resignation. S.F.
- (7) I, **Mr. Shahin Pourgol**, acknowledge that the College has previously provided me with a copy of the relevant provisions of the *Medicine Act* and, in particular, sections 9 and 11 of the *Medicine Act*, as well as the *RHPA*, and in particular section 33 of the *RHPA*. The College has previously advised me that I am acting in contravention of the *Medicine Act* and the *RHPA* and further advised me that violating certain provisions of the *Medicine Act* or the *RHPA* is an offence at law. S.F.
- (8) I, **Mr. Shahin Pourgol**, acknowledge that the College may in its discretion post this Undertaking or information regarding this Undertaking on its public website, and may provide this Undertaking and/or any information relevant to the subject matter of this Undertaking to any individual for the purposes of monitoring my compliance with this Undertaking. S.F.


UNDERTAKING

- (9) I, **Mr. Shahin Pourgol**, undertake to abide by the provisions of this Undertaking, effective immediately.
- (10) **Restrictions**
- (a) I, **Mr. Shahin Pourgol**, undertake that I will permanently refrain from using the title "doctor" and/or "physician" and/or any variation or abbreviation thereof, including M.D., and will permanently refrain from using the title "osteopath" and/or any variation or abbreviation thereof, and further undertake not to hold myself out as a physician or osteopath in the course of providing health care services to any individual. S.F.
- (b) I, **Mr. Shahin Pourgol**, undertake that I will permanently remove the title 'doctor', or 'osteopath' from my website, advertisements, brochures, business cards, receipts, letterhead and/or other documents, including email addresses, and will ensure that other individuals and/or corporations do not use these titles in association with my name. (I will remove all above mentioned, whenever in future I decide to start delivering to the people of Ontario health care. Currently I don't treat patients and as such I am permitted to use the title doctor).

ACKNOWLEDGEMENT

- (11) I, **Mr. Shahin Pourgol**, acknowledge that I have read and understand the provisions of this Undertaking and that I have obtained independent legal counsel in reviewing and executing this Undertaking, or have waived my right to do so. S.P.
- (12) I, **Mr. Shahin Pourgol**, acknowledge that a breach by me of any provision of this Undertaking may result in the College taking legal action against me, including commencing an application in court for injunctive relief. S.P.


